Year-Round Legal Clerkship

The German-Southeast Asian Center of Excellence for Public Policy and Good Governance ('CPG'), an academic institute and think tank attached to the Faculty of Law at Thammasat University in Bangkok, regularly inviting German trainee lawyers interested in European and Constitutional Law to apply for a three-month Legal Clerkship ("Rechtsreferendariat").

About CPG

Established in 2009 and carried by the German universities of Münster and Frankfurt and Thammasat University in Thailand, CPG is one of only five Centers of Excellence worldwide within the framework of the Excellence Initiative of the German Federal Government. It is funded by the German Ministry of Foreign Affairs (Federal Foreign Office) and supported by the German Academic Exchange Service (DAAD).

In its law related activities CPG's work centers on the fields of international and constitutional law, human rights, national security, law reform especially in the justice sector and the intersection of law and politics and international relations respectively.

In keeping with its mission, CPG is active in academic research and education as well as in training and consultancy and supports a wide circle of stakeholders.

CPG is also the institution behind *Asia in Review* ('AiR') and *Europe in Review* ('EiR'), two forthcoming innovative multimedia providing a unique source of information on constitutional law, domestic politics, human rights, national and collective security and defense, international relations, geopolitics and regional order in Asia and Europe respectively.

Roles & duties

Requirements & Conditions

CPG's Legal Clerkship is open to all law graduates currently undergoing practical training (Rechtsreferendariat).

At CPG we look for well-rounded, motivated individuals who are intellectually curious and are practical in their approach; who enjoy a challenge and seek new opportunities; and who take responsibility and use their initiative.

All Clerks are expected to possess excellent research, writing, and organizational skills.

Depending on the pandemic situation, clerkships are offered both on-site and remotely.

How to apply

Applications must be submitted via email to Ms. Venus Phuangkom (careers@cpg-online.de) and should include:

- A <u>cover letter</u> setting out briefly the candidate's interest in the position,
- A <u>curriculum vitae</u> (CV),
- Certificate of the First State Exam, and
- A portrait photo (jpeg).

We will respond to every application as soon as we can. Usually this is within 10 working days of receipt of your application, though at busy times it can take a bit longer.
